APPEAL, PETITION AND COMPLAINT

COMES NOW, the Plaintiff above-named, and for a cause of action against the above-named Defendant, appeals, petitions, complains and alleges as follows:

I.

Plaintiff, MICHAEL JORGENSON (hereinafter "Jorgenson"), at all times relevant hereto is and was a resident of Kootenai County, State of Idaho, a registered voter and elector of legislative district three, and a candidate for public office therein.

APPEAL, PETITION AND COMPLAINT-1

Defendant, DAN ENGLISH (hereinafter "English") was at all times relevant hereto the Clerk of Kootenai County, State of Idaho and acting in his official capacity thereto.

III.

In March, 2010 Steven Vick declared his candidacy for State Senator of District Three, Kootenai County, State of Idaho.

IV.

On April 23, 2010 Senator Jorgensen notified the Defendant, Clerk of Kootenai County, that the proposed candidate, Steven Vick, was not qualified, as he is not a registered voter of Kootenai County due to the following facts:

- Mr. Vick registered as a voter with Kootenai County on October 8, 2004 as evidenced by the certified copy of Exhibit "A" attached to this Complaint.
- 2. Mr. Vick subsequently registered to vote in the State of Montana on March 20, 2006 as evidenced by the certified copy of Exhibit "B" attached to this Complaint.
- Two days later, on March 22, 2006, Mr. Vick executed a *Declaration for Nomination* for public office in the state of Montana, affirming that he was a resident of Montana, evidenced by the certified copy of Exhibit "C" attached to this Complaint.

V.

Senator Jorgenson also advised the Defendant of the existence of Idaho Code § 34-405 which states in relevant part: "If a person is absent from this state but intends to maintain his residence for voting purposes here, he shall not register to vote in any other state during his absence."

APPEAL, PETITION AND COMPLAINT-2

On April 26, 2010 the Defendant, Kootenai County Clerk, refused to declare that Mr. Vick is not a registered voter of Kootenai County, State of Idaho.

VII.

The Defendant, as Kootenai County Clerk, has a duty to the citizens of Kootenai County to maintain the register of electors of Kootenai County and from time to time, update, purge and cancel registrations of individuals no longer meeting the necessary qualifications, and to ensure all registered voters of Kootenai County meet the appropriate qualifications.

VIII.

The Defendant, as Kootenai County Clerk, owes a duty to all registered voters of Kootenai County, including Senator Jorgenson as an elector and candidate, to apply and interpret the election laws of Kootenai County equally and without prejudice.

IX.

The Defendant, as Kootenai County Clerk, in his interpretation and application of Idaho law and in his failure to declare that Mr. Vick is not a registered voter, has breached his duty to Plaintiff and all registered voters of Kootenai County.

X.

Defendant's breach has proximately caused injury and damages to all registered voters of Kootenai County, including Plaintiff and particularly injuring Plaintiff as a candidate for Legislative District Three, all in a manner which will be proven at trial.

APPEAL, PETITION AND COMPLAINT-3

JURISDICTIONAL STATEMENT

This Court has jurisdiction to provide the relief requested pursuant to Idaho Code § 34-215 which states:

APPEALS BY AGGRIEVED PERSONS. (1) Any person adversely affected by any act or failure to act by the secretary of state or a county clerk under any election law, or by any order, rule, regulation, directive or instruction made under the authority of the secretary of state or of a county clerk under any election law, may appeal therefrom to the district court for the county in which the act or failure to act occurred or in which the order, rule, regulation, directive or instruction was made or in which such person resides.

WHEREFORE, Plaintiff prays for judgment as follows:

- For an order reversing the Kootenai County Clerk's interpretation of Idaho law and decision regarding the status of Steven Vick.
- 2. For an order declaring that Steven Vick is not a registered voter of Kootenai County.
- 3. For other and further relief as to this Court appears just and equitable.
