**OPTION # 1 - RENEWAL LEVY**

SHALL THE BOARD OF TRUSTEES OF COEUR D'ALENE SCHOOL DISTRICT #271, KOOTENAI COUNTY, IDAHO, BE AUTHORIZED AND EMPOWERED TO LEVY A **SUPPLEMENTAL MAINTENANCE AND OPERATIONS LEVY** as permitted by law in Section 33-802(3), Idaho Code for seven million eight hundred twenty eight thousand six hundred eighty seven dollars (\$7,828,687) each year for two (2) years for a total amount of fifteen million six hundred fifty seven thousand three hundred seventy four dollars (\$15,657,374) for the purpose of paying all lawful expenses of maintaining and operating the schools of the District for the fiscal years beginning July 1, 2011 and ending June 30, 2013?

If Option 1 fails, Option 2 cannot pass.

IF **OPTION # 1 PASSES**, SHALL THE BOARD OF TRUSTEES OF COEUR D'ALENE SCHOOL DISTRICT #271, KOOTENAI COUNTY, IDAHO, BE AUTHORIZED AND EMPOWERED TO LEVY AN **ADDITIONAL SUPPLEMENTAL MAINTENANCE AND OPERATIONS LEVY** as permitted by law in Section 33-802(3), Idaho Code for five million thirty eight thousand seventy five dollars (\$5,038,075) each year for two (2) years for a total amount of ten million seventy six thousand one hundred fifty dollars (\$10,076,150) for the purpose of paying all lawful expenses of maintaining and operating the schools of the District for the fiscal years beginning July 1, 2011 and ending June 30, 2013?
