#### 2. Text Data:

  - iii. Using commonly readable file format set by agreement.
- Text data files relating to transactions produced according to 2a shall include field descriptions (e.g., file number, date/time, description, and amount).

### 3. Image Data:

a. Image data shall be produced in graphic data files in a non-proprietary or commonly readable format with the highest image quality maintained.

## 4. Encryption/Authentication:

- Electronically stored records may be transmitted in an encrypted container. Decryption keys shall be produced separately at the time the data are produced.
- b. Authentication, such as hash coding, may be set by agreement.
